



The complementary nature of these two data sources (behavioral plus medical) when used together, gives carriers a powerful tool for identifying groups with the greatest potential to deviate materially from the pricing basis. Equipped with this knowledge, a carrier can use the scores from these two tools to refine pricing, triage new opportunities, or modify benefits or rate guarantee offerings.


